If you have a concern about the service you have received from the clinicians or any member of practice staff, please let us know. We operate a practice feedback procedure as part of a NHS complaints system, which meets or exceeds national criteria.

How to Submit Negative Feedback

We hope that we can sort most problems out easily and quickly, in many circumstances at the time that they arise and directly with the person concerned. If you wish leave negative feedback, please do so **as soon as possible** - ideally within 24 hours. This will enable us to establish what happened more easily. Where this is not possible your negative feedback should be submitted within 12 months of the incident that caused the problem; or within 12 months of discovering that you have a problem. You should address your feedback in writing or email to Alison Laidler, Patient Services Coordinator, using the attached form. They will make sure that we deal with your concerns promptly and in the correct way. You should be as specific and concise as possible when outlining your concerns.

Submitting Negative Feedback on Behalf of Someone Else

We abide strictly to the rules of medical confidentiality (a separate leaflet giving more detail on confidentiality is available on request). If you are not the patient, but are providing feedback on their behalf, you must have their permission to do so. A consent form signed by the person concerned is required, unless they are incapable (due to illness or infirmity) of providing this. This is included in **Section 4** of the form.

What we will do

We aim to acknowledge your feedback within 3 working days and to have it fully investigated within 10 working days of the date it was received. If for any reason the investigation is taking longer, we will explain the reason for the delay and tell you when we expect to finish. When we look into your feedback, we will investigate the circumstances; make it possible for you to discuss the problem with those concerned; make sure you receive an apology if this is appropriate, and take steps to make sure any problem does not arise again.

You will receive a final letter setting out the result of any practice investigations.
